In order to protect your rights and facilitate your understanding of how the university collects and uses your personal information, please make sure that you carefully read all of the contents in this agreement.

一、基本資料之蒐集、更新及保管

Collection, update and safe-keeping of basic information

 本校蒐集您的個人資料在中華民國「個人資料保護法」與相關法令之規範下,依據本校 【個資保護管理要點】,蒐集、處理及利用您的個人資料。

The university collects, processes, and uses your personal data in accordance with the MCU Guidelines for Personal Information Protection Management, which were established based on the Personal Information Protection Act and relevant laws and rules enacted in Taiwan, the Republic of China.

- 2.請於申請時提供您本人正確、最新及完整的個人資料。
 Please provide your accurate, most recent and complete personal data.
- 3.本校因執行業務蒐集您的個人資料,包含中英文姓名、ID(護照號碼)、性別、身高、體重、血型、婚姻、國籍、宗教信仰、專長領域、出生地、地址、電話、行動電話、傳真、EMAIL、學歷、經歷等相關人事基本資料,詳如填寫欄位。

Your personal data collected by the university to facilitate its administration includes the information in the columns marked as required on the form, such as Chinese and English name, ID No. (Passport No.), gender, height, weight, blood type, marital status, nationality, religion, professional specialty, birthplace, mailing address, telephone number, mobile number, fax number, e-mail address, educational history, experience and relevant personnel information.

- 5.若您提供錯誤、不實、過時或不完整或具誤導性的資料,您將損失相關權益。
 You may lose related rights or benefits if you provide incorrect, untrue, outdated or incomplete information.
- 6.您可依中華民國「個人資料保護法」,就您的個人資料行使以下權利:
 According to the Personal Information Protection Act (ROC), you are entitled to make the following requests:
 - (1)查詢或請求閱覽。To check or review the collected data
 - (2)請求製給複製本。To receive a photocopy of the collected data
 - (3)請求補充或更正。To supplement or revise the collected data.
 - (4)請求停止蒐集、處理或利用。To cease the collection, processing or use of the collected data.
 - (5)請求刪除 To delete the collected data.

但因本校執行職務或業務所必須者,本校得拒絕之。若您欲執行上述權利時,請參考本校 【個資保護管理要點】之個人資料保護聯絡窗口聯絡方式與本校連繫。但因您行使上述權 利,而導致權益受損時,本校將不負相關賠償責任。

However, the university may reject your requests in order to meet the administrative and operational needs of its offices. Moreover, should you suffer any losses or diminished rights due to such requests, the university shall not be held responsible for any related compensation.

- 二、蒐集個人資料之目的 Purpose of Personal Data Collection

The university collects your personal data for the following purposes to meet the needs of educational administration and personnel administration in accordance with the specific purpose and the classification of personal information in the Personal Information Protection Act as announced by the Ministry of Justice.

四、基本資料之保密 Basic Information Security

您的個人資料受到本校【個資保護管理要點】之保護及規範。本校如違反「個人資料保護法」規定或因天災、事變或其他不可抗力所致者,致您的個人資料被竊取、洩漏、竄改、遭其他侵害者,本校將於查明後以電話、信函、電子郵件或網站公告等方法,擇適當方式通知您。Your personal information is protected by MCU Guidelines for the Personal Information Protection Management. Should your personal information be stolen, disclosed, altered or infringed upon due to the violation of the Personal Information Protection Act by the university due to the occurrence of any natural disasters, incidental changes or other unavoidable circumstances, the university shall inspect the cause and inform you by phone, mail, email or website notice.

五、同意書之效力 Validity of Agreement

- 1.當您勾選「我同意」並簽署本同意書時,即表示您已閱讀、瞭解並同意本同意書之所有 內容,您如違反下列條款時,本校得隨時終止對您所提供之所有權益或服務。
 - Your signature on this agreement indicates that you have read, understood and accepted its contents. If you breach any terms of this agreement, the university may terminate all the rights and services given to you whenever it deems necessary.
- 2.本校保留隨時修改本同意書規範之權利,本校將於修改規範時,於本校網頁(站)公告修改之事實,不另作個別通知。如果您不同意修改的內容,請勿繼續接受本服務。否則將視為您已同意並接受本同意書該等增訂或修改內容之拘束。
 - The university is entitled to amend the contents of this agreement, and any amendments will be publicized on the university website. Should you disagree with any amendments, please exercise your right to request that the university discontinue to collect, process or use your personal data. Otherwise, you are considered to have agreed to this amendment.

Unless otherwise expressly provided herein, no suggestion or information, neither in written format or orally delivered, that you may obtain in connection

with this agreement, constitutes any guarantee outside this agreement.

六、準據法與管轄法院 Governing Law and Jurisdiction

本同意書之解釋與適用,以及本同意書有關之爭議,均應依照中華民國法律予以處理,並以臺灣台北地方法院為管轄法院。

The interpretation and application of this agreement shall be governed by the laws of the Republic of China. Any disputes arising out of or relating to this agreement shall be submitted to Taiwan Taipei District Court as the court of jurisdiction.
